

Monsignor Slade Catholic School Tuition Raffle Guidelines

Prize: One year of tuition for one eligible student in Pre-K4 through 8th Grade for the 2027–2028 school year, subject to the terms below.

Ticket Sale Dates: August 27, 2026 – December 17, 2026. Ticket purchasers must be 21 years of age (or older).

Drawing Date: December 18, 2026

Cash Option: Not available

Valid At: Monsignor Slade Catholic School only

Purpose: All raffle proceeds will benefit the Monsignor Slade Catholic School Home and School Association (HASA).

1. **Grand Prize.** The Grand Prize consists of tuition for one eligible student in Pre-K4 through 8th Grade at Monsignor Slade Catholic School for the 2027–2028 school year. It cannot be used toward prior-year balances, future years beyond the 27-28 school year, or other outstanding obligations.
2. **Tuition Only.** The prize applies to tuition only. It does not cover registration fees, technology fees, activity fees, extended care, uniforms, books, meals, transportation, fundraising obligations, or any other fees or charges unless expressly approved in writing by Monsignor Slade Catholic School.
3. **Eligibility to Redeem Prize.** To redeem the tuition prize, the student must be enrolled or accepted for enrollment at Monsignor Slade Catholic School for the 2027–2028 school year and must remain in good standing under school policies.
4. **Application of Discounts, Aid, or Subsidies.** If the winning student receives a tuition discount, scholarship, financial aid, or other reduced tuition rate, the prize will apply only to the family's actual tuition obligation after all discounts, aid, subsidies, and benefits have been applied. The prize will not result in a cash payment, refund, or credit beyond the family's actual tuition obligation.
5. **Transferability Within Family.** The prize may be applied to an eligible student in the winner's immediate family who is enrolled or accepted for enrollment at Monsignor Slade Catholic School for the 2027–2028 school year. The prize may not be transferred to another family, school, or educational institution. Once the Grand Prize recipient designates the student, they must submit that decision in writing to the principal. Upon receipt, that decision is final.

6. **Ineligible Participants and Recipients.** HASA board members, their immediate family members, and all Monsignor Slade Catholic School employees, including faculty, staff, and EduCare personnel, are not eligible to purchase raffle tickets or win the tuition raffle. Eligibility will be determined as of the date of the drawing. If an ineligible person is selected as the winner, an alternate winner will be drawn.
7. **No Cash Value.** The prize has no cash value and may not be redeemed for cash, credit, refunds, or any other form of compensation.
8. **Ticket Sales.** Raffle ticket sales will begin on August 27, 2026, and conclude on December 17, 2026. Ticket price, purchase instructions, and any ticket limits will be communicated separately by HASA.
9. **Drawing and Notification.** The winning ticket will be drawn on December 18, 2026. The winner does not need to be present to win unless otherwise stated in the final raffle materials. The winner will be notified using the contact information provided at the time of ticket purchase. The winner must respond within 10 business days after notification. If they cannot be reached or fail to claim it, an alternate winner can be selected.
10. **Withdrawal/Early Departure.** If the winning student withdraws from Monsignor Slade Catholic School during the 2027–2028 school year, whether by family decision or at the discretion of the School, any unused portion of the tuition prize does not convert to cash, is non-transferable, and is forfeited upon withdrawal, unless the School determines otherwise.
11. **Taxes and Reporting.** The winner is responsible for any federal, state, or local taxes or reporting obligations that may apply to the prize. Monsignor Slade Catholic School may require the winner to complete appropriate tax or verification forms before the prize is awarded or applied.
12. **Compliance With Law.** The raffle will be conducted in accordance with applicable laws, regulations, and school policies. The School reserves the right to modify, postpone, cancel, or clarify the raffle rules as necessary to comply with applicable requirements.
13. **Cancellation or Postponement.** If the raffle is cancelled before the drawing, ticket purchasers will be notified, and refunds will be handled in accordance with school policy. The School reserves the right to cancel if a minimum number of tickets is not sold. If the drawing is postponed, the updated drawing date will be communicated to ticket purchasers.
14. **Final Decisions.** By purchasing a raffle ticket, participants agree to abide by these raffle rules and all decisions made by Monsignor Slade Catholic School and HASA, which shall be final.
